DIRECTIONS FOR USE

Prior to mixing, shake the concentrate well. Keep lights and fans off for 2-3 hours after application.

CURATIVE

Mix at 1.2% or 45 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating until there is runoff. Wait 4 hours, then repeat application a second time. Treat every 3-5 days as necessary.

For maximum effectiveness, apply at the first sign of disease and use a sprayer that emits a fine mist for full coverage.

PREVENTATIVE

Mix at 1.2% or 45 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating until there is runoff. Treat every 7 days. No limitation on the number of applications per growing cycle. No need to add a surfactant.

STORAGE

Keep product at room temperature away from direct sunlight. Do not freeze.

DISPOSAL

Dispose of waste material in accordance with federal, state and local environmental laws and regulations. Recycle bottle when empty and do not reuse.

PRECAUTIONS/FIRST AID

Avoid getting in eyes or on skin or clothing. Harmful if swallowed. Impervious gloves, a long sleeved shirt and pants are recommended for applicators and other handlers to prevent prolonged skin contact. If contact occurs, wash with large amounts of soap and water for 15-20 minutes. If in eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation.
