DIRECTIONS FOR USE: Prior to mixing, agitate the concentrate well. For outdoor application, spray plants early in the morning or evening. For indoor application, keep lights and fans off for 2-3 hours after spraying.

CURATIVE: Mix at 1.2% or 45 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating, including the undersides of leaves, until there is runoff. Wait 4 hours, then repeat application a second time. Treat every 3-5 days as necessary.

For maximum effectiveness, apply at first sign of disease and use a sprayer the emits a fine mist for full coverage.

PREVENTATIVE: Mix at 1.2% or 45 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating until there is runoff. Treat every 7 days.

No limitation on the number of applications per growing cycle. No need to add a surfactant.

PRECAUTIONS/FIRST AID: Avoid getting in eyes or on skin or clothing. Harmful if swallowed. Impervious gloves, a long-sleeved shirt and pants are recommended for applicators and other handlers to prevent prolonged skin contact. If contact occurs, wash with large amounts of soap and water for 15-20 minutes. If in eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation.

STORAGE: Keep product at room temperature away from direct sunlight. Do not freeze.

DISPOSAL: Dispose of waste material in accordance with federal, state and local environmental laws and regulations. Recycle tote when empty and do not reuse.
