**DIRECTIONS FOR USE:** Prior to mixing, shake the concentrate well. For outdoor application, spray plants early in the morning or evening to avoid the hottest part of the day. Avoid spraying in temperatures over 90°F. For indoor application, keep lights and fans off for 2-3 hours after spraying.

**PREVENTATIVE:** Mix at 0.25% or 10 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating until there is unoff. Shake during use. Repeat this process every 7 days.

**CURATIVE:** Mix at 1.0% or 40 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating until there is runoff. Shake during use. Repeat this process every 3-5 days, as necessary.

No limitation on the number of applications per growing cycle. No need to add a wetting agent.

**PRECAUTIONS/FIRST AID:** Avoid getting product near extreme heat, sparks and open flames. Avoid getting in eyes or on skin or clothing. Eye protection is recommended. Direct eye contact may cause irritation. If in eyes, rinse repeatedly with clean water for 15 minutes. Protective gloves are recommended to prevent prolonged skin contact with concentrate. If on skin, wash with plenty of water. Harmful if swallowed. Obtain medical attention for any persistent irritation.

**STORAGE:** Keep product in its original container in a cool, dry location away from direct sunlight. Store in temperatures between 65°F and 80°F. Do not freeze.

**DISPOSAL:** Dispose of waste material in accordance with federal, state and local environmental laws and regulations. Recycle bottle when empty and do not reuse.
